Hello Jill,

I hope you're well. We're reaching out because we've been overwhelmed with requests for information, and have received an outpouring of requests. I'll summarize below:

- (1) The LFKHDB website is missing the entirety of 2024's Minutes. Please update with 2024, and the Public is urging the District to remain compliant with these ongoing.
- (2) The Public requests that the documents section of the LFKHDB website maintain documentation which is within the rights of the Public to review. It is currently very limited in documentation. The Public requests all documents relating to HMA, CHS, Kennedy Drive, Health Systems, and the matter of the Lease of our Public Hospital. We believe it would be more practical to simply have a document section which would link to a drive with all documents which the Public (and the appointed Community Appointees, who have also requested these) have the right to review, without naming or requesting documents which the Public wouldn't have knowledge of. It would be much more practical to have these available on the website, versus responding to individual requests.

I realize this is a big ask, I'm just the messenger. Thank you in advance.

- (3) The Public requests Agenda's be published for their attendance when arriving at the Public Meetings, and further in advance on the LFKHDB website.
- (4) The Public requests the LFKHDB name the location of the meeting no later than 14 days in advance.
- (5) The Public requests a formal sign-up sheet to accommodate Public Speaking requests, and written rules to follow for Public Speaking. In the event the rules have changed from the historical 5 Minutes for an organization, 3 Minutes for an individual, or have changed in any other way, provide the Public Notice for these changes.

We anticipate the Public meetings will grow significantly, please prepare to accommodate the Public's right to participate in these meetings for the foreseeable future.
